WHAT ARE COOKIES AND OTHER TECHNOLOGIES?

Cookies are small files sent by websites you visit and stored on the device you use to access those sites. When users visit the same site again, the browser reads the cookies stored on the device and transmits the information back to the site that originally created or installed those cookies.

Cookies are divided according to their duration into:

- session cookies, when they are automatically deleted at the end of the browsing session; and
- Permanent cookies, when they remain stored on the user's device even after the closure of the
 browsing session, for a time established by the creator of the cookie itself. These cookies are
 automatically deleted once the pre-set duration period has elapsed or alternatively, they can be
 deleted directly by the user as indicated in the "Manage cookies" section of this Cookie Policy.

Depending on where they come from, cookies can be divided into:

- first-party cookies, when they are set and managed directly by the site manager; and
- third-party cookies, when they are managed by a domain other than the one visited by the user.

In addition, cookies are divided according to their function into:

- technical cookies, which are necessary for the operation of the site, including the provision of information society services requested by users; and
- profiling cookies, aimed at creating user profiles and used in order to send and show advertising messages in line with the preferences expressed by the user while browsing.
